

Trustees increase ITPE Health and Welfare Benefits

As Co-Chairman of the District 1-ITPE-MEBA/NMU Health and



Welfare Fund, it gives me great pleasure to announce that the Board of Trustees significantly increased Surgical Benefits

from \$1,500 to \$2,350 for all ITPE members (Class IV) effective November 1, 1991 during meetings held this past October.

For those members now receiving contributions at the 79¢ level, the following increases were realized for Class IV employees: Hospital Indemnity has been increased to \$290 (from \$175); Hospital Miscellaneous was upped from \$1,800 to \$4,000; Supplemental Sickness now pays \$525 per year (as compared to \$350): and Diagnostic X-Rays were increased to \$450.

Death Benefits for Employees were also increased from \$4,000 to \$6,000 and \$2,000 to \$3,000 for Dependents. It is expected that all ITPE contracts will be brought up to the 79¢ levels under collective bargaining agreements scheduled to take effect October, 1992.

The Trustees are currently contemplating doing a study to see what the cost to the Fund will be to initiate a Drug Prescription Program.

All in all, a job well done by the Board of Trustees, to which your initial ITPE officers belong.

We welcome aboard our new ITPE Division Officials who have been elected to new three-year terms in office.

Elected as ITPE Division Chairman was John Conley, who, as all of you know, has been an official for many years in Seattle and Savannah, as both Agent and Patrolman, and most recently as ITPE National Representative.

Ralph Smith was elected as the ITPE Division's Vice Chairman. Ralph is one of our original ITPE organizers dating back to the 1970's. Prior to that he sailed aboard many of our Deep Sea vessels and was one of our former NMU officials.

The three elected Directors are John Brenton, III, Theatla (Ruthie) Jones and Mary Williams. Brenton is a third generation Union member. His grandfather sailed in the N.M.U. as well as his father John Brenton. Jones, our ITPE Representative in Las Vegas, has been doing a great job servicing our taxicab drivers for a number of years. Williams has been servicing our shoreside installations since the early 70's and has done a terrific job as one of our organizers as well.

I also wish to Congratulate the elected Delegates to our District and National Conventions. Their names appear on page 5 as well as the Report of the Credentials Committee which certifies that the Division officials heretofore mentioned as well as the names of the delegates which appear on page 5 are unopposed.

REPORT OF THE CREDENTIALS COMMITEE 1991 ITPE ELECTIONS

This Credentials Committee, elected pursuant to Article Seven, Section 3(a) of the ITPE Division By-Laws, met on September 12th, 1991, at ITPE Division Headquarters in Savannah, Georgia, and examined the nominating petitions for the offices of Division Council and Delegates to the District and National Conventions which were received at the Headquarters of the ITPE Division, 19 East Perry Street, Savannah, Georgia, and made the following findings:

- 1. Disqualified the nomination petitions of Herman L. Edwards and Gloria Lockwood because they failed to have the endorsement of twenty-five (25) members in good standing as required by Article Seven, Sections 2(a) and 2(c) (5) of the ITPE Division's By-Laws.
- 2. Sent telegrams to Ms. Lockwood and Mr. Edwards, informing them of their right to appear before the Committee in accordance with Article Seven. Section 3(c) of the ITPE Division By-Laws. In addition, certified letters (return receipt requested) were sent to both such disqualified persons, notifying them of the reasons for disqualification and of their right to appeal the action of this Credentials Committee in accordance with Article Seven, Section 3(c) of the ITPE Division By-Laws.
- 3. Noted, without further action, the written withdrawals by Margie M. Cox, Carmen Z. Diaz and Jeff T. Myers, of their nominating petitions.
- 4. Noted that in accordance with the District Constitution, ITPE Division By-Laws and Notice of Nominations, nominations were open for the positions of Chairman, Vice Chairman, three

Service Contracts Committee strives to improve bargaining process

Elwood Hampton, Organizing Coordinator, has been representing ITPE-MEBA/NMU interests on a special Union Service Contract Committee. This Committee is made up of representatives of five AFL-CIO International Unions with special service contracting interests.

The Committee was formed because of much narrower and specialized service contract interests which need detailed discussion and action. The Committee has been able to meet on a regular basis of about once every two months to focus Federal Procurement policies pertaining to collective bargaining, price adjustments, and organizing on military installations.

As a result of the efforts of this

Committee, unique Department of Defense formed a similar Committee of Defense Labor Advisors. The two Committees meet quarterly to discuss material procurement questions. In addition, since the two Committees represent a significant segment of the procurement environment, the Department of Labor Representatives have also attended many of the Committee's meetings to provide government input into the discussions.

It is anticipated that the importance of the Committee will increase as the cost of contracting for services becomes a greater factor in contracting. The Committee will undoubtingly become the focal point for improved collective bargaining at a reasonable price.

Amendments

During the Plan year ended March 31, 1991, the following amendments were adopted to the plan's document:

Amendment No. 90-1 to the ITPE-MEBA/NMU Annual Benefit Plan

- 1. The filing of an application shall not be required for the payment of holiday benefits. Such payment will be made automatically by the Plan.
- 2. Employees, who start employment after the effective date of the collective bargaining agreement, shall be eligible for accrual of sick leave benefits after the completion of 90 days of service with the Employer.
- 3. New Benefits Added.
- A. A Bereavement Benefit is payable in the event of the death of a spouse, parent, child or sibling, This benefit is payable after the completion of 90 days of service with an Employer.
- B. Jury Duty Benefit up to five days will be payable for service as a juror in any court or record.

Amendment No. 90-2 to the ITPE-MEBA/NMU Annual Benefit Plan

Employees eligible to receive a holiday or sick leave benefit as of September 1, 1990, were entitled to an additional benefit, which was equal to two days of holiday benefit. The calculation period was June, July and August 1990. This special benefit was payable on December 1, 1990, only.

Amendment No. 90-1 to the Agreement and Declaration of Trust Establishing the ITPE-MEBA/NMU Annual Benefit Fund

Increased the size of the Board of Trustees to five Employer Trustees and five Union Trustees. Up to three Alternate Trustees may be appointed by both the Union and the Employers.

Amendment No. 91-1 to the Agreement and Declaration of Trust Establishing the ITPE-MEBA/NMU Annual Benefit Fund

Increased the size of the Board of Trustees to seven Trustees designated by the Union and seven Trustees designated by the Employers. Each side may designate two Alternate Trustees.

Amendment No. 91-2 to the Agreement and Declaration of Trust Establishing the ITPE-MEBA/NMU Annual Benefit Fund

Liquidated damages will be assessed if payment is not received from an Employer by the close of business on the 15th day of the second month following the month for which contributions are due. If an Employer becomes delinquent in its contributions to the Fund for a period of two months or more, liquidated damages at the rate of 20% shall be imposed on such Employer, if payment is not received from such Employer within 10 days following the due date for all months of delinquency subsequent to the first month. In addition, all contributions received by the Fund shall be credited towards the earliest month for which contributions remain due at the time of receipt.

NATURE AND PURPOSE

The ITPE-MEBA/NMU Shannon J. Wall—Happy I. Franklin Scholarship Program was established by the Board of Trustees to assist the sons and daughters of eligible participants to provide an opportunity for a post high school education for the sons and daughters covered by the ITPE-MEBA/NMU Welfare Plan. Five four-year scholarships for study at a college or university in amounts up to \$5,000, and two two-year vocational/technical scholarships will be awarded each year in the amount of up to \$2,500.

All phases of the scholarship competition, including selection of winners and determination of the amount of scholarship awards, are handled by the College Scholarship Service-Sponsored Scholarship Programs. The College Scholarship Service is a program of the College Board.

ELIGIBILITY

To be eligible, the candidate must be a high school senior who will graduate in January or June of the current school year, and who is an eligible participant, or a son, daughter, step-son, step-daughter, or legally adopted child of an eligible participant.

For the purpose of this program, an eligible participant is one who has been a participant of the Plan for one year (definition of one year—200 hours in year of application).

RULES AND PROCEDURES FOR ITPE-MEBA/NMU SHANNON J. WALL -HAPPY I. FRANKLIN SCHOLARSHIP PROGRAM

Each Scholarship award, per year, will be based on the tuition and fees, room and board, books transportation and other legitimate educational expenses at the school of the winner's choice. The ITPE-MEBA/NMU Shannon J. Wall—Happy I. Franklin Scholarship Program are four-year awards, renewable after the first year for an additional three years, or until the student completes requirements for a bachelor's degree, whichever is first.

The vocational/technical awards of the ITPE-MEBA/NMU Shannon J. Wall—Happy I. Franklin Scholarship Program are for vocational courses of six months to two years duration. If the student enrolls in a vocational/technical program which requires more than one year for completion, the award will be renewable for up to an additional year.

To qualify for renewal of a college award or a vocational/technical award, the student must be maintain scholastic and personal standards acceptable in the judgement of the school officials and the Scholarship Committee.

All applicant's scores will be reviewed to determine who the winners are.

Winners are selected by an independent committee whose training and experience qualify it to evaluate total high school records, including academic work, test scores, extracurricular activities, leadership qualities, high school recommendations and the student's own statements. This committee meets in the winter to review the credentials of all semifinalists. Each folder is reviewed by two members of the committee and rated according to standards established by the College Scholarship Service. Each candidate is then ranked according to the committee's review. In the ITPE-MEBA/NMU Shannon J. Wall—Happy I. Franklin Scholarship Program competition, the first seven candidates are identified as alternates. If for some reason a candidate identified as a winner does not accept the award, the first alternate would then be offered the award. If necessary, this procedure would take place down the line of alternates.

In the Vocational/Technical scholarship competition, the winners are selected by an independent committee whose training and experience qualify it to evaluate total high school records, including academic work, work experience, extracurricular activities, high school recommendations and the student's own statements. This committee meets in the winter to review the credentials Or all Vocational/Technical applicants. Each folder is reviewed by two members of the committee and rated according to standards established by the College Scholarship Service. Each candidate is then ranked according to the committee's review. The top candidates are identified as winners.

Each candidate must be willing to accept the Scholarship Committee decision as final.

CHOICE OF INSTITUTION

The recipient of a scholarship may attend any accredited college or university, or any qualified vocational/technical school which does not permit discrimination based on race, creed, or color in (l) its overall enrollment policies; (2) enrollment for any part of its curriculum; or (3) the use of any of its facilities.

College award winners must be enrolled in a course of study leading to a bachelor's degree at an accredited college or university. Transfer of a college scholarship to another accredited college will be permitted only between academic years upon written approval of the Scholarship Committee.

Winners of the vocational/technical awards must pursue a course of study leading to a specific career-directed certificate or diploma in a vocational or technical curriculum of at least six months duration. Transfers to another vocational school will not be permitted. The student may select any state, federal or nationally accredited institution or junior college offering vocational or technical curricula. The course of study must be taken at a vocational/technical school accredited by an agency recognized by the U.S. Office of Education, or a regionally accredited junior college offering vocational or technical curricula, or a hospital school of nursing accredited by the National League of Nursing. Curricula leading directly to a baccalaureate degree are not eligible for the vocational/technical awards; courses taken through correspondence schools are not acceptable.

PAYMENT OF SCHOLARSHIPS

Upon a scholarship winner's enrollment at an approved school, the amount of the scholarship award will be deposited annually with the school in the name of the student to be used for authorized expenditures. Any surplus remaining from the yearly award shall revert to the scholarship fund. Neither the ITPE-MEBA/NMU Shannon J. Wall Happy I. Franklin Scholarship Program not the Board of Trustees can accept any responsibility for the conduct, personal affairs, debts or obligations of a scholarship winner, and they shall not be liable therefore in any manner.

OBLIGATIONS OF SCHOLARSHIP WINNERS

The scholarship winner must enter an approved college, university or vocational/technical school no later than the fall of the year in which the scholarship is awarded. Except for accident, illness, or other extenuating circumstances, the student will be required to continue study without interruption. Any delay or interruption of studies must be reported promptly to the Scholarship Committee.

A scholarship winner may not accept other competitive awards.

PERMANENCY OF THE PROGRAM

The Scholarship Programs have been established in the confident expectation that they are to be continued indefinately. It is recognized that conditions conceivably may require changes or modifications. The right to modify or terminate the programs, in whole or in part, is reserved. In the event of such change, scholarships in effect will be continued for their duration.

HOW TO APPLY

A single application form is used to apply for one of the ITPE-MEBA/NMU Shannon J. Wall—Happy I. Franklin Scholarships. An application may be obtained from any NMU branch officer or from ITPE-MEBA/NMU Welfare Plan, P.O. Box 23679, Savannah, Georgia 31403-3679. Detailed instructions are attached to the application.

The application must be filed no later than December 1 for the applicant to be considered for a scholarship award in the following calendar year. Scholarships will ordinarily be awarded in the spring for use in the next school year.

Application for a scholarship does not constitute application for admission to the school. It is the responsibility of each winner to apply for admission to the school of his choice and to fulfill the admission requirements.

The Board of Trustees has committed itself to pay vacation, holiday, sick leave, training, jury duty and bereavement pay incurred under the terms of the Plan.

Basic Financial Information

The value of the plan assets, after subtracting liabilities of the plan, was \$711,737 as of March 31, 1991 compared to \$644,978 as of April 1, 1990. During the plan year, the plan experienced an increase in its net assets of \$66,759. This increase includes unrealized appreciation or depreciation in the value of the plan's assets at the end of the year or the cost of assets acquired during the year.

During the plan year, the plan had total income of \$1,777,837 including employer contributions of \$1,662,259, earnings from investments of \$88,877 and other income of \$26,701.

Plan expenses were \$1,711,078. These expenses included \$420,645 in administrative expenses and \$1,290,433 in benefits paid to and on behalf of participants and beneficiaries.
